Announcement of Changes in Representative Directors and Executives, and the New Management Team

Tokyo, April 25, 2023 – Sony Financial Group Inc. ("SFGI") resolved the proposed changes in Representative Directors (change of President & CEO), Directors, and Audit & Supervisory Board Members as stated below at a Board of Directors' meeting held today. The election of the new management team is subject to the approval of the Ordinary General Meeting of Shareholders, as well as of the Board of Directors' meeting, both to be held on June 23, 2023.

(2) Reason for Changes

The appointment of Mr. Toshihide Endo is aimed at further strengthening the management structure of the Sony Financial Group. In addition to possessing a wealth of experience and insight into financial administration, acquired during his tenure as former Director of the Financial Services Agency, Mr. Endo has knowledge of a diverse range of fields including corporate governance, human resource strategy, sustainability and international economic affairs. He currently provides the Sony Group Corporation with advice from various perspectives in his capacity as Senior Advisor to the company. Under its new leadership, SFGI will continue to pursue sustainable enhancement of corporate value.

Comment from Masashi Oka

"Since I was appointed President & CEO of SFGI in June 2020, management has focused on driving profitable and sustainable growth, strengthening the Group governance system, and otherwise working to enhance the overall management quality of the Sony Financial Group. We have successfully carried out the Mid-Range Plan (FY2021-2023) to date under the key principle of "maximizing corporate value through self-transformation," making steady progress in building a foundation for sustainable enhancement of corporate value. As the final year of the current Mid-Range Plan, FY2023 is also the year in which to formulate our next Mid-Range Plan. Two of our main operating subsidiaries, Sony Life Insurance Co., Ltd. and Sony Assurance Inc. will also transition to new management teams. We therefore decided that this is a good time for turning management of the Sony Financial Group over to a new leader, and consequently asked Mr. Toshihide Endo to assume the role of President & CEO. I am confident that under his guidance, informed by his deep knowledge of the financial industry and proven track record in leadership, the Sony Financial Group will make another leap forward."

"I am deeply grateful for the trust that Mr. Masashi Oka, the Board of Directors of SFGI, and the Sony Group Corporation have placed in me, and am keenly aware of the profound responsibility that it entails.
